

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.worldbit.com and Valuebit International Ventures Pte. Ltd. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Valuebit International Ventures Pte. Ltd. include www.worldbit.com, Valuebit, worldbit, worldbit.com and wallet.worldbit.com, intel.worldbit.com. The Valuebit website is a Augmented Reality Marketplace site. By using the Valuebit website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Valuebit may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- wallet address, hash id

If you purchase Valuebit's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. ## Sharing Information with Third Parties
